### REPORT ON GENERAL BODY MEETING-2022

Student Welfare Committee of Sri Devaraj Urs college of Nursing in association with SNA Unit of SDUCON had conducted General Body meeting on 12.03.2022 between 9.30am to 11am at Silver Jubilee Auditorium of SDUAHER. Meeting commenced with warm welcome to all students and committee members by Mrs.V.Saritha, member secretary of Student welfare committee.

Member secretary, Mrs.V.Saritha, Tutor presented the group on the agenda to be discussed as follows;

1. Curricular related activities
2. Clinical activities
3. Hostel related activities
4. Any others

#### 1. Curricular related activities:

With regard to this, Ms. Nandini, IV year B.Sc. (N) student, as a representative of all students, raised the questions and discussed the following points with committee members as follows:

Questions raised by students	Discussions and Decision
Request for half day leave on every Saturday	As our College planned curriculum in such a way that apart from syllabus, even certificate course need to be implemented. Apart from this in the campus, all educational institution the management fixed third Saturday as a holiday. Hence, we require adhering to the same.
Increased Fee structure	The College is not Collecting separate fees except tuition fees. Each time of value added course/ record book/ conference it was advised for us that cash should not be collected from students, so we have planned the amount to add along with the Fee structure and collect at once, hence it is done.
Library timings	As per students request to increase the library timings, it was accepted and informed to the Class Co-coordinators to work in co-ordination with Librarians and to place batch wise rotation to the students to utilize Library between 4.30pm to 5.30pm after the class hours.

## 2. Regarding clinical related activities

Questions raised by students	Discussions and Decision
Request for OT postings (All OT)	It was discussed that, as per the curriculum requirement, students will be permitted to go for OT postings after obtaining necessary permission from the authorities, by concern class coordinators in coordination with clinical coordinator at the earliest.
Change of Clinical starting time at 8am instead of 7.30 am	As class, coordinators planned their batch wise Master and Clinical rotation plan with starting of 7.30am. So we cannot change with present academic year and students has to adjust with the same timings and cooperate.

## 3. Regarding Hostel related activities

Questions raised by students	Discussions and Decision
Request for General Medications in the hostel	It was informed to the students that, first aid kit is available with emergency medications, under the control of Wardens or Health secretaries (in the absence of warden). Further it was decided that, the medications will be used based on the need of the student during emergency and the same need to be replaced later by the candidate.
Room allotment( 03 in each)	Members presented that due to shortage of rooms and increase strength of students, students are requested to adjust for some days meanwhile will discuss with management and make necessary arrangements.
Permission for outing and Home pass for localities in the week end(third Saturday)	It was informed to the students that, outing stopped due to covid-19 pandemic. Now with specific timings outing and week end home pass on third Saturday will be permitted.
Request for Non-Veg in mess menu	As per the request, it was informed to the students that, due to covid-19 pandemic, Non-Veg was stopped and daily egg was initiated. Now as per the previous menu plan, Non-Veg will be provided on Wednesday night and Sunday afternoon.

## 4. Any others

Questions raised by students	Discussions and Decision
Request for space to have food by day scholar students	As per the request, it was informed to the students that, the Management has planned to provide separate

	seating arrangement next to the college building and work will be starting shortly.
Request for visiting hours to office & Principal	<ul style="list-style-type: none"> <li>• It was informed to the students that, every day from 12 pm and after 4pm students can meet the principal. With regard to the office during lunch hour if not take prior permission with class coordinator and meet.</li> <li>• If any parents want to meet principal, they should take prior permission through class coordinator to meet Principal.</li> <li>• If any parents want to stay in campus, a request letter can be given by student three days prior to book the guest room.</li> </ul>
Request for bus facilities who travels from distant places.	It was informed to the students, since localities are limited in number it cannot be provided and College provides bus facility for staff and the same can be utilized in emergency.

With above all discussions and suggestions, member secretary thanked to all and meeting adjourned at 11am.
