Sub: Institutional Research Policy - reg.

This is for the information to all teaching faculty that in order to create /encourage/motivate a research environment within the Institution and to involve mote research activities, the Institution has created a policy (Ref. No.SDUCON/586/2018-19, dated 23-01-2019 received on 08-05-2019 & Ref. No. SDUCON/035/2019-20, dated 16-04-2019 received on 25-04-2019) as follows:

1. Seed money for research projects other than UG/PG projects.

In order to inculcate research culture among faculty Rs.5000/- has sanctioned from management per department as seed money for research projects other than UG/PG projects. Hence each dept. faculty is informed to submit the research project proposals each academic preferably on the thrust areas in a prescribed format (Annexure 2B.) along with the estimated budget plan. Selected proposals need to be presented by the principal investigator in research committee pre approval. Pre approve proposals will be further proposed for Institutional Ethics committee clearance. The application for seed money has to be forwarded by HOD and the Principal to research committee of SDUCON.

2. Incentive to teaching faculty for scientific publications in various journals.

Granting Incentive to teaching faculty for scientific publications in various journals was discussed in research committee and got approved from the management on 23-01-2019 in order to create a rich research environment in the Institution.

A. The type of articles considered for the incentives shall be:

- Invited review articles (systemic review and Meta-analysis),
- Original research articles.
- Case series.
- Short communication

B. The types of journals and incentives for publications:

Articles published in journals with in Thomson Reuters Impact factor and journals Indexed in Scopus or PubMed will receive

- Zero to 0.5= Rs.12,500/-(Twelve thousand five hundred only)
- >0.5 to 1= Rs.15,000/-(Fifteen thousand only)
- >1 to 1.5 =Rs.17, 000/-(seventeen thousand and five hundred only)
- >1.5 to 2=Rs.20,000/- (Twenty thousand only)
- >2.00 to 30,000(thirty thousand only)

Note:

- The incentive amount would be equally distributed among all the authors and they should obtained IEC certificate separately for the start of study and publication
- The names and their order mentioned in IEC certificate issued for start of the study should be same in certificate issued for publication and also in the published article.
- Faculty who has resigned, incentive will not be considered for P.G. and PhD. Scholars
- Faculties UG/PG/PhD studies/Guided studies are not considered.

3. Publication charges shall be paid by SDUCON directly to publisher/journals only if

- Prior approval has been taken from research committee at the time of presentation
- Authors submit required documents regarding publications charges(articles accepted for publication) well in advance to research committee of SDUCON with a covering letter forwarded through proper channel mentioning details of journals, subject speciality, Scopus or PubMed indexed with impact factor, copy of articles accepted for publication, correspondence from journal regarding acceptance and publication charges, details related to payment, copy of ethical certificate issued by the institution.
- If publication charges are paid by SDUCON, proportionately the publication charges shall be deducted from the incentives paid to faculty
- If publication charges will not be considered for P.G/UG/PhD. Scholars.
- Publication charges cannot be considered if the criteria proposed is not acceptable

4. Incentives for Book Publication:

The incentives would also be provided to an author who contributes a chapter in a text book or reference book published by a national or international/publishers or in an institutional level. The amount of incentives would be Rs.5, 000/-(Five thousand only)

The incentives for the textbook/reference books solely authored published by a national or international/publisher or at an institutional level. The amount of incentive would be 20,000/-(Twelve thousand only)

5. Any other:


Any other faculty before applying for mural/extramural research grants should bring to the notice of research committee and can proceed further. Timely progress need to be informed to the committee.



Any teaching faculty of SDUCON who are participating/presenting scientific papers at national/international conferences/workshops, CNE programmes in the respective field of their study of specialization need to get prior permission (minimum 2 week early) and the study should have been approved in the institutional research and ethics committee. Such studies are eligible for reimbursement (Registration fee and TA/DA) provided they submit the certificate after attending the programme

In case of any changes in their projects/dissertations details need to bring to the notice of research committee before finalizing at the department level.

6. As soon as mini project/dissertation is completed, plagiarism certification is must before submitting dissertation to the university and submit one hard copy of the abstract to the research committee.




