

(ii) **Sri Devaraj Urs Medical College**, a constituent college of Sri Devaraj Urs Academy of Higher Education and Research (SDUAHER) situated at Tamaka, Kolar, the party of the second part hereinafter called **SDUMC** represented by **Principal** hereinafter called the college stipulates as under

1. That SDUCON have approached the SDUMC to seek facilities and permission to conduct classes of Para medical subjects for undergraduate nursing students and Statistics class for undergraduate and post graduate nursing students after having agreed on the following commitments from either side and on the financial considerations as under.

OPERATIONAL COMMITMENTS

The SDUCON shall provide

Infrastructural facilities

- Lecture Theatre (LT) to accommodate 100 plus students
- Audio Visual Aids in the LT including Projector, Screen, Speakers, Fans, Lights, Electricity, black board etc. for conducting the classes
- Internet connectivity


Manpower: Concerned class co-ordinator makes arrangement to handle the classes.

SDUMC shall provide related laboratory teaching learning facilities

2. Remuneration shall be paid to the faculty per hour for the classes engaged and it will be as per the consultancy policy of SDUAHER.
3. There will be periodic evaluation process of students to enhance the teaching learning process. Both parties may request more frequent review in response to curricular and other institutional changes and conditions. The information obtained from the evaluation will be used for the benefit of students.



4. Both the parties to this MoU shall, in true letter and spirit, commit to provide best services to the students.
5. The agreement shall remain in force for a period of 3 (three) years from the date of signing the agreement, till any of the either parties gives notice to get released from the mutual commitments. The agreement may be terminated by giving at least 6 months' notice to either side subject to completion of the ongoing batch/course.
6. Any other terms may be included in this MoU as per mutual acceptance / requirements, but shall be effected in writing.
7. Disputes, if any shall be subject to mutual arbitration at Sri Devaraj Urs Academy of Higher Education and Research campus.


